 - i. All PDF attachments must be **password protected**. The email quotation must reach within stipulated date and time on following email addresses: dir.camd@nac.com.np; dymdir.epd@nac.com.np; bmahato@nac.com.np.
 - ii. Please note that email attachment should exclusively in PDF format. If email attachment size is greater than 5 MB please send multiple emails with each attachment less than 5 MB.
 - iii. After the deadline of submission of sealed quotation, NAC shall request / email the bidders to submit the password. The password shall be provided **via separate email** at dir.camd@nac.com.np; dymdir.epd@nac.com.np; bmahato@nac.com.np after request from NAC within prescribed date and time.
 - iv. Any email quotation without password protected and password submitted beyond duration mentioned in (iii) above shall not be considered.
 - v. It is the responsibility of bidder to ensure that quotation sent through email(s) shall reach within stipulated date and time.
 - c. Air freighted / couriered:
 - i. Please note it is responsibility of bidder to make sure that the air freighted/couriered quotation shall reach mailing address mentioned in GT&C (1) above in this document. The sealed quotation, if air freighted/couriered from abroad, would be accepted even without wax sealed on the envelope.
